

Preparing your Canadian return while away from Canada

There are a few options available to you when you are preparing your Canadian return while away from Canada:

Option 1: By email, fax or mail

Here's how it works:

Step 1: Tell us about your tax needs

- Complete the [Tax Questionnaire](#)
- Gather your tax documents, including:
 - A copy of your previous year's Notice of Assessment
 - Your tax slips (e.g. T4s, RRSP receipts, T4As, etc.)
 - Any other documents or receipts that you feel are important (e.g. medical or donation receipts)

Step 2: A Tax Expert will contact you

A Tax Expert will contact you to:

- Ask for any additional information they need to complete your tax return(s)
- Provide a *no-obligation* estimate for the cost of your tax preparation as well as an estimate for how long your return(s) will take to prepare

Step 3: We'll prepare your tax return

Once you give the go-ahead, your tax return(s) will be prepared by your Tax Expert, ensuring that you have the highest possible refund or the lowest possible tax liability.

Step 4: Approve your return and we'll file it for you

Your return will be securely shared with you over epost. You can review it and request changes if required. When you're satisfied, simply sign your return to approve it. We'll file with the CRA (and Revenu Québec if applicable) and send you the filed copy.

Step 5: Relax! Your taxes are done!

This service supports all tax scenarios.

Option 2: Online Tax Expert

- 2018 and 2019 returns only
- T1 (personal) tax returns only
- Must have a Canadian mailing address

At this time, the service does not support the preparation of returns for deceased persons or AgriStability.

Here's how it works:

Step 1: Create an account

Visit our Online Tax Expert service at <https://www.hrblock.ca/online-tax-expert/> and click on **Get Started**. You can learn more about the service, including the cost, on the website.

Step 2: Tell us about your tax needs

Follow the prompts on your Online Tax Expert dashboard. You will be asked to create a tax profile, confirm your identity, authorize H&R Block as your representative, and upload your tax documents (using pictures from a mobile device and/or scanning).

You'll be guided step-by-step, with access to a Tax Expert along the way, to ask any questions you may have.

Important:

- Use the **Messages** tab on your dashboard to send a message letting us know that you are a Canadian living abroad.
- If you are unable to pass the identity confirmation required for this service, please consider switching back to **Option 1: By email, fax or mail**.

Step 3: Pay for your service

Complete a secure, online payment for the Online Tax Expert service.

Step 4: Your tax return is prepared

Your Tax Experts will complete your tax return and file on your behalf. Don't worry, you'll get a chance to review everything before we file! Any documents that require signing can be completed online, so there's no printing required.

Step 5: Relax! Your taxes are done!

Frequently Asked Questions

Which option should I choose?

We are excited to offer you two tax preparation options when you are outside of Canada: by faxing, mailing, or emailing us your documents and a completed [Tax Questionnaire \(option 1\)](#), or by using our brand-new Online Tax Expert service ([option 2](#)).

The benefit of the Online Tax Expert service is that all your correspondence is done online through a personalized dashboard, and the cost for the service is a flat fee (the same cost no matter how complex your taxes are). However, because this is a new service, it cannot fully support all tax scenarios. Read through the information provided in this package to learn more about the restrictions on who can use this service. If you do not qualify for the Online Tax Expert service or prefer to communicate over the phone rather than online, we'd suggest you choose option 1.

How much do these services cost?

Option 1: If you choose to **fax/mail/email** us your tax information, your Tax Expert will provide you with a no-obligation estimate prior to the completion of your tax return, once they have had a chance to review your specific situation.

How do I pay you?

Option 1: If you choose to **fax/mail/email** us your tax information, you can pay using Visa, Mastercard, or American Express. Payment can be made over the phone or through a secure Canada Post epost Connect conversation ([learn more](#)). We do not accept payment by email money transfer (EMT).

Option 2: If you choose to use the **Online Tax Expert** service, you will be prompted to pay on your personalized dashboard through a secure online transaction by Visa, Mastercard or American Express.
