Description: DELTAZYM® VR XL Conc. is a concentrated xylanase liquid preparation obtained

from *Trichoderma reesei*, used for viscosity reduction during cereal processing. DELTAZYM® VR XL Conc. hydrolyses  $\beta$ -1,4-xylans and, to a certain extent,

 $\beta$ -1,3/1,4-glucans found in cereals, especially barley and oat.

used for the fermentation process and in the final formulation.

Composition: DELTAZYM® VR XL Conc. is stabilised with sodium chloride and preserved with

small amounts of potassium sorbate and sodium benzoate.

Packaging and storage: DELTAZYM® VR XL Conc. is available in 25 kg polyethylene drums. The product is

best stored in the original and unopened packaging under refrigerated conditions

(4-8°C) in order to retain maximum activity during storage.
