Documentation of AutoPASS Agreement</p> <p><i>The HC Card holder must be the legal owner of the AutoPASS agreement.</i></p> <p><i>The name of the HC Card holder and the tag number must appear in the same document.</i></p> <p><i>If the HC Card holder is under 18 years old, the AutoPASS agreement must be registered to a parent or guardian.</i></p>

Decision Letter from the Municipality</p> <p><i>If the validity date of the HC Card is less than 2 years from the day you apply for exemption, remember to include the decision letter you received from the municipality.</i></p> <p><i>This is necessary for us to know that the HC Card has a validity of at least 2 years.</i></p>
