Obtaining CDS MSS Data

HMRC expect UK importers and exporters to have processes in place to manage their customs compliance. One key way to manage compliance is to obtain MSS Data.



MSS Data is the customs declaration data, usually submitted by the nominated customs agent, which is archived for 4 years. Any importer or exporter, with a GB EORI, can obtain this data from HMRC. There is currently a charge for this service of £20 per report per month. Where required, a company can also obtain historical data for the same fee. This data is used by HMRC when determining which imports/exports require examination as part of a Customs Audit, so it is very useful data.

How do I apply for the data?

Firstly you will need to access the .Gov page relating to MSS Import and Export Data. Complete the Customs Declaration Service agreement and upload your covering letter on the Customs Declaration Service (CDS) agreement form. The following points are important to ensure the form is correctly completed:

- **1 Match:** The dates on page 1 and the covering letter match.
- 2 Name: Applicant (or 3rd party) company name is completed.
- **3 Historic:** Wish to receive historic data and dates for data to cover are specified (if relevant).
- **4 Ongoing:** Wish to receive data ongoing is specified and start month matches cover letter and above (if relevant).
- **5 Total:** The Report options per month required are ticked.

- 6 Postal address: Postal address of the applicant company is completed.
- **7 Emails and names:** Up to three email addresses and names of email address holders are provided. Email addresses can be team/group ones.
- 8 Applicant or 3rd party applicant (if relevant).
- 9 Data recipient (if different to either of above).
- 10 Invoice recipient.
- 11 EORI: All required EORI numbers are provided.
- **12 Authorised:** Authorised person (not 3rd party) is specified regarding:
 - Signature
 - · Forename and surname
 - · Company position.

A covering letter must be provided with the agreement submission. An example of the required text can be downloaded **here.**

Once the form has been submitted to HMRC's UK Trade Info Team, the company contact will receive an email with the invoice for payment. Once payment is received by HMRC, separate emails will be issued to the contact to provide the MSS Data and Password.
