






Traditional Trail Development

Future Conflicts/Challenges








Streamlined Process

 - Amenities Selection




\$2M Congressional Earmark, for each jurisdiction to develop a pilot project






Cobb County: Silver Comet Trail & Noonday Creek Trail Extensions

 Sidepaths










Paulding County Trails and Greenways Master Plan



- RS&H completed a
 comprehensive greenway
 and trail master plan in
 2008
- Plan will add over 70 miles of trails
- Uses the Silver Comet Trail as a spine
