LOG INTO BLUELINK & SET UP OCU EMAIL

FINANCIAL INFORMATION

File the FAFSA

Graduate financial aid works a little different than undergraduate financial aid, but it still begins with filing the FAFSA (Free Application for Federal Student Aid—FAFSA.ED.GOV). Once you have completed your FAFSA, contact Student Financial Services at 405.208.5211.

4 STUDENT HEALTH INSURANCE REQUIREMENT

OCU requires that all students (on-campus and remote) maintain health insurance coverage as a condition of enrollment. The insurance fee for the OCU SHIP (Student Health Insurance Plan) is automatically billed to your student account each semester.

If you already have health insurance coverage that meets the university's requirements, there is a SHIP waiver available, which will allow you to waive the university's SHIP and maintain your current insurance coverage.

Fully online students do not need to complete the health insurance waiver.

5 IMMUNIZATION REQUIREMENT

Oklahoma law requires all students—including grad students—to be vaccinated:

- Hepatitis B
- MMR (Measles, Mumps, Rubella)

Physician Assistant, Nursing, and on-campus students require proof of additional vaccination.

The Campus Health Clinic requires an immunization record on file before August 1.

6 SUBMIT FINAL DOCUMENTS

Please check with your graduate admission counselor to determine if you need to submit any final, official documents following your admission. OCU requires all students to have final, official transcripts from each institution attended. These transcripts are also required to be on file with the university by the Department of Education before you can receive any federal financial aid.

7 STUDENT ID

The StarCard is the official ID card of OCU. Pick up your StarCard after enrolling in courses prior to the start of classes. Your StarCard can be picked up at the Student Accounts office on the 3rd floor of the Administration Building.

- Printing at computer labs
- The Aduddell Fitness Center

PROGRAM SPECIFIC NOTES

Music Students

Look over the schedule of Advisory Exams, Performance Leveling, Instrumental Ensemble Chair Placement, and Dance Leveling at okcu.edu/music/admissions/incoming-students/graduate. There is also a mandatory Academic Orientation before classes begin.

Doctoral Nursing Students

All students in DNP and PhD nursing programs are required to attend orientation. Doctoral students also attend three-day intensives prior to each semester. Check with Sherri Christian (schristian@okcu.edu) or your advisor for more detailed information.

MFA Creative Writing Students

All MFA in Creative Writing students are required to attend 10-day online residencies each January and July. Contact the Program Director, Rob Roenschh (rgroensch@okcu.edu) for more detailed information.

MFA in Screen Acting Students

The MFA in Screen Acting program will hold a series of virtual events. These 90 minute events will be part academic orientation, part Meet the Faculty, and part general program updates/Q&A. OCU CAMPUS RESOURCES

A. Campus Parking

OCU annual parking permits are good from August-July of each year. Parking permits are required of any student, staff, or faculty wishing to park on campus. The permits are available for purchase at the Student Accounts Office beginning in August. okcu.edu/financialaid/parking-permit.

B. On-Campus Housing & Dining
