

#### Episode 12: June 2022 | The Dating Game

#### Answer: 1982

Gladys McCoy was an Oregon pioneer, serving as the first [Black] member of both the Portland School Board and the Multhomah County Board of Commissioners. In 1986, she was elected as Multhomah County Chair. She was reelected to that office in 1990 and served until her death on April 11th, 1993. McCoy's accomplishments during her tenure were extensive. In 1989, she established a model program for delivering human and justice services at the Columbia Villa housing project (where she had lived early in her residence in Portland). She also stabilized County funding, expanded and met County affirmative action goals, increased citizen participation in government, increased minority representation on County boards and commissions, and standardized the County charitable contribution program.

In this 1982 image, McCoy and Multhomah County Sheriff Don Clark inspect confiscated gambling machines that were likely seized during raids that took place in 1981. The photograph comes from a series of public relations images in the Archives' Gladys McCoy collection.





#### Episode 11: May 2022 | Construction Junction

#### Plans for the historic Vista House Preside in the Road Services records collection.

The aptly named structure perches 733 feet above the Columbia River. Multhomah County Assistant Highway Engineer Samuel Lancaster proposed an observatory along the newly constructed (but now Historic) Columbia River Highway. It was intended to provide a rest stop for travelers to marvel in the views along and across the river. It also served to commemorate the challenges that early pioneers had endured on their journeys to Oregon Territory. Renowned Architect Edgar M. Lazarus designed the octagonal building in the Art Nouveau style. John B. Yeon, the County's road master supervised its construction with public funding from the County.


Vista House opened in 1918 and has charmed the public ever since. It






