The IDEA project, initiated by industry, managed by an independent Supervisory Group, is politically supported by the Commission through an annual review. The project's objective, to develop high quality safety assessment in the area of fragrance allergens, is of key concern for the Commission.

10.15 – 10.30 THE IDEA PROJECT AFTER THREE YEARS (Prof. Jim Bridges – chair of IDEA Supervisory Group)

The IDEA project is designed to provide a broadly agreed and transparent framework for assessing fragrance sensitizers globally via the development of strong partnerships between the international fragrance industry and its stakeholders. Three years after its official kick-off, this Annual Review should allow to monitor the progress made and identify the key priorities to be addressed.

10.30 – 11.15 QRA METHODOLOGY UPDATE SINCE LAST ANNUAL REVIEW (Prof Jim Bridges)

One of the four important tasks to be tackled by the IDEA project is the development of a systematic and scientifically-robust methodology to prevent consumers from getting sensitized to allergens. In that end, significant time and efforts have been dedicated to the revision of the Dermal Sensitization QRA. An interim report has been submitted to the EU Commission.
