Job title:	QSHE Manager
Function:	To lead all aspects of developing, implementing and maintaining agreed QHSE and other operating standards. Working as part of an integrated team linking with Business Managers; staff teams and SHE representatives.

Duties:

- Develop, maintain and improve the business Integrated Management System to underpin QHSE and operating standards
- Maintain a risk register, reviewing QHSE risks and escalating where appropriate.
- Maintain a legal register to ensure compliance with relevant legislation and regulations.
- Support the training and development of all staff to ensure awareness and understanding of QHSE Standards and the relevance to business objectives.
- Implement, monitor and update Emergency Management Plans across all sites and ensure robust line of escalation exists.
- Provide a single business focus for accident and incident reporting and assist with subsequent investigation process; provide trend analysis to support and provide focus for driving positive behaviours and culture within the business.
- Develop Business Continuity Plans for all service streams and participate in any live exercises to test the plans.
- Monitor, audit and report on QHSE performance and provide assurance to Tower Senior Leadership Team
- Maintain quality, safety and environmental systems; implement, audit and update all associated documentation to achieve compliance with ISO 9001, 14001 and 45001.
- Maintain the management system and identify and implement initiatives to improve it including all procedures, processes, safe systems of work, carrying out and offering support and advice on Risk Assessments, Method statements and COSHH.
- Ensure appropriate resources are provided to support a compliant business and to identify any systemic weaknesses.



- Advice, guide, support, promote awareness and coach all personnel with the implementation of the company's policies and procedures. Complete other projects at the request of the Management
- Ensure all essential tasks ("A") assigned to you are completed daily, weekly and monthly as required.
- Any other duties as may be required from time to time.

Qualifications

- The role of the HSEQ manager will require a recognised safety and environmental qualification (diploma level or equivalent) and should hold an auditor's qualification for and have experience in ISO 9001, 14001, 18001.
- NEEBOSH diploma in Occupational Health and Safety qualification preferred to level 3
- NVQ level 4/5 Occupational Safety and Health Practice.
- IMEA (Institute of Environmental Management & Assessment) preferred

Machinery	Ensure supply partners and Tower employees work in accordance with health and safety, Quality, Environmental and IT/Internet policies and procedures.
