## Terms & Conditions

Membership of Nailcote Hall Hotel Leisure Club ("the Club") is conditional upon observance of the Club rules, a summary of which is set out below. These Rules have been drawn up by the Proprietor of the Club, Mr R W Cressman, with the intention that the Club's facilities can be utilised safely and to their fullest extent by all Members and their guests, without affecting in any way their use by others.

1. The membership subscription shall be fixed annually and shall be paid annually in advance on the 1st day of April. Appropriate adjustments will be made for those who join within 12 months of the 1st of April.

(a) The subscription may be varied by the Club from time to time and members shall be notified of any variations in the subscriptions prior to the date of their annual renewal.

(b) Absolute discretion is granted to the Club to reject any application for Membership without giving any reason.

(c) On acceptance of application, all new members will be provided with a membership card, which will remain the property of the club. On termination of membership, the card is to be returned to the Club on demand. Lost membership. Cards will be replaced but a charge will be made.

(d) Membership shall be renewed by payment to the Club of the annual subscription then in force on the expiry date. The Club may refuse to renew a membership without giving any reason.

(e) The Club reserves the absolute right to terminate without prior written notice the membership of any members if payment of any money due to the Club is in arrears for more than 30 days.

2. Members must carry their cards when visiting the Club and produce it on demand to Club Officials. Such cards are not transferable and their loss must be reported immediately to the Club.

3. The Club may at any time withdraw all or any part of the facilities for any period of time where the same are required for use by the Nailcote Hall Hotel or its guests or in connection with any repair, alteration or maintenance work to the facilities, the Club, or the Hotel.

4. Members, guests and visitors must wear a form of dress appropriate to the time of the day and place on all occasions.

5. All guests must be accompanied by Members, signed in at the Club's reception and pay the appropriate guest fee. Members must ensure that their guests abide by the Rules of the Club and accept responsibility for their guest's behaviour. The same guest may not be introduced more than six times in the Club year.

6. Membership of the Club may be terminated by a member at any time. Any refund is at the sole discretion of the Club. The Club reserves the right at its sole discretion to refuse admission and/or cancel membership forthwith if any member shall in the opinion of the Club cause nuisance or annoyance to the other Club Members or their guests.

7. The Club will not accept responsibility for any harm that may come to a member or guest because of their undertaking within the Club any activity which is beyond their physical capability.

8. The Club will not accept liability for the safety of members' personal property brought on the Club site unless these are handed into the Club reception for safekeeping and a signed receipt is given. Property stored in lockers provided by the Club or its agents is stored at the owner's risk and no liability will be accepted by the Club. Cars parked in the car park or elsewhere on the premises of the Club and all contents in them are left at the owner's risk and the Club accepts no liability whatsoever in respect of them.

9. The Club cannot accept liability for any accident to any member that may occur on the premises or within the grounds of the Club. All accidents on the Club premises or in the Club grounds must be reported to the Duty Manger immediately following the accident.

10. No pets will be allowed in the Club buildings or grounds, with the exception of guide dogs.

11. Entry to the Club is only permitted at the Club reception entrances.

12. All lost property found on the premises is to be handed in to the Club Reception. Lost property will be disposed of after three months.

13. Members are required to comply with all reasonable directions that the Club Manager may give to ensure the smooth operation of the Club, the use of the facilities and the convenience of all Members.

14. Any dispute or difference which may arise regarding the interpretation of these Rules, shall be determined by the Proprietor, whose decision shall be final and binding on all Members of the Club.

15. The proprietor of the Club reserves the right to amend these Rules at any time and without notice to individual members, but notification of the change will be posted on the Club Notice Board.

16. Members and their guests shall comply with Club Rules and with directions given by Club Management and staff and with the particular instructions for use of individual facilities.
